Documents/Information required for processing a Student Visa:

Before arrival in UAE, the applicant must submit the following:

- Completed Visa Application Form (above)
 - Clear passport copy applicant must have a passport valid for a minimum of 180 days when applying for a visa).
 - Clear coloured passport size photograph with (white background) required specification found at: https://axs2.my.site.com/resource/1637155751000/EIDA_photo_specifications
 - 25% of tuition fee payment for the appropriate year of study.
 - Visa fee payment for the appropriate year of study.
 - refundable deposit payment.
- For applicants wishing to transfer visa from within the UAE, the following documents must be submitted in addition to points 1 – 6 above:
- Tourist visa copy (or) residence cancellation paper (must have at least 30 days validity).
 - Previous Emirates ID copy (If available)

Note: Indian citizens holding a valid US Green Card, or a valid residence visa/visa issued by the UK or EU, are eligible for a 14-day visa-on-arrival in the UAE. However, this visa cannot be converted to a student visa unless the individual holds a proper tourist visa processed through an airline, a travel agent, or sponsored by a local dependent.

Following arrival in UAE, the applicant must submit the following documents to the Visa Office within 3 working days:

- Entry Permit copy with UAE immigration entry stamp.

Visa Application Guidelines

Heriot-Watt University provides student visas through Dubai Knowledge Park for international students seeking to study at the Heriot-Watt University Dubai Campus. The Dubai Development Authority (TECOM) is the sponsor of foreign students enrolling at Dubai Knowledge Park Authority.

Criteria

1. Visa sponsorship is only available for students who have received an unconditional offer and who have enrolled on a programme with the University.
2. Procedures for sponsorship cannot commence until the student has accepted an unconditional offer letter and paid all relevant fees.
3. A student's visa is normally valid for a period of 12 months. Students in undergraduate programmes will be required to renew their visa every year of the programme.
4. Residence visas are required for all international students.
5. Due to restrictions relating to international student visa sponsorship, students on university-sponsored visas would not be able to sponsor a residence visa for their family members.

Information

6. Students must apply in sufficient time (usually 4 to 6 weeks in advance) of the commencement of the programme.
7. Student visa applications from some countries may have to undergo additional security checks or may be required to submit additional documentation by the UAE government authorities. This is outside the control of the University and may cause further delay in the processing time. If, for whatever reason, the visa is not available before the enrolment deadline then the student would not be allowed to pursue the programme for that particular intake. The University cannot be held liable for any such circumstances. In such cases, the existing visa would be cancelled. The student may choose to re-apply for a new student visa and start in the next available intake.
8. Students applying late may choose to apply for a UAE tourist/visit visa to be in time for the start of the programme. If, for whatever reason, a student visa is not issued to the student, then the student would not be allowed to pursue the programme further. The University cannot be held liable for any such circumstances. Furthermore, students will be liable to pay any tuition/visa/other fees due as per the University policy.
9. All students applying for a university-sponsored visa must undergo a UAE medical check. In the event of a student failing the medical test, the visa may not be processed further, and the student may be required to leave the country and not be enrolled on the programme of study. The University cannot be held liable for any such circumstances.
10. You will be required to undertake a blood test and chest X-ray for HIV (AIDS), Hepatitis B, Hepatitis C, Tuberculosis (TB) and Leprosy. If results come back positive for any of those conditions, it is highly likely that you will be deported; therefore, it is advised to take a test in your home country before travelling.

11. Visa fees are beyond the control of the University and are subject to change. In case of an increase by the government authorities, the student will be liable to pay the additional visa charge(s).
12. The student will need to meet any charges incurred for transferring the money in addition to the fee itself. The student must also send a copy of the funds 'telegraphic transfer issuing' advice, along with the visa application form, to help identify the payment. Please check with the bank when transferring the funds for details.
13. Any fines, penalties, or additional charges incurred as a result of an error, delay, late submission, loss of documents etc. by the student, will be borne by the student.
14. All visa fees are non-refundable. For details on visa sponsorship fees, please refer to the 'Application Guidelines and Fee Structure' document. Students whose visa application is rejected by Immigration will have their visa deposit refunded, less any visa processing charges already levied.
15. Students will be responsible for all costs relating to processing a new/renewal visa if they wish to continue at Heriot-Watt University Dubai Campus.
16. In case of deferral, suspension or withdrawal of a student who is on the University's sponsored visa, the student visa is required to be cancelled. A new student visa will have to be applied for if the student wishes to rejoin. The student would be liable to pay all visa-related fees in such cases.

Renewal of Visa

17. It is the responsibility of the student to submit all documents/payments for a visa renewal at least 30 working days before the date of expiry of the visa.

Cancellation of Visa

1. Please be informed that your Student Residence Visa must be cancelled immediately once the student completes their program of study or terminate, suspend, withdraw, transfer, or defer studies at the Dubai campus. The visa cancellation process will be carried out promptly, and the student will be responsible for arranging departure from the UAE or securing alternative sponsorship. This process typically takes approximately 10–15 working days.
2. Even if the student visa has expired, whether the student is inside or outside the UAE, the visa cancellation fees must be borne by the student. The visa can only be legally cancelled through the University proper procedures, and your name will not be removed from the immigration system unless the cancellation is processed officially.
3. In case a student does not cancel his/her student visa, he/she may be required to pay additional visa cancellation costs. Furthermore, the University may report such students to the Immigration authorities as absconders and the visa deposit amount paid by the student will be utilized to process the absconding request, wherein the student will not be able to enter the country on any visa in the future.
4. Upon leaving the country and after visa cancellation, students must send their exit confirmation via email to dubai university visa office. Students failing to do so will be liable to pay a charge for airport authority clearance.
5. If you change your visa within the UAE, please submit a copy of your residence visa or Emirates ID to deactivate your immigration file. Once your name is cleared from the immigration system, your visa deposit will be refunded, unless any visa fees have been charged.
6. If the printout shows that the student has exited, the visa immigration systems record is closed. In case the immigration printout shows that the student is in-country, the student will be registered as an absconder and the fee taken from the student deposit payment.
7. A student's visa will be cancelled in the following circumstances:
 - o Where the student does not complete enrolment with the University.
 - o When a student has been convicted of a criminal offence.
 - o When a student does not comply with the rules and regulations required by the University.
 - o Inside UAE visa cancellation fee **AED 861/-**
 - o Outside UAE visa cancellation fee **AED 1659/-**
 - o Visa cancellation fees are beyond the control of the University and are subject to change. In case of an increase by the government authorities, the student will be liable to pay the additional cancellation charge(s).
