# Heriot-Watt University Role and Function of the Deans Refreshed – March 2020

### 1. Introduction

This document sets out the identifiable tasks currently carried out by the Deans as specified in the Charter and Statutes and the Ordinances and Regulations of the University. The document is intended to inform the election of Deans in the course of 2020.

#### SUMMARY

- 1. The existence of Deans is determined in the University Charter and Ordinances. The relevant Ordinance (L1) states there shall be three Deans, who are members of the academic Staff.
- 2. One Dean is elected by academic Staff across the whole University, and two are elected from academic Staff in specified broad academic groupings.
- 3. The post of Dean is a secondary appointment, comprising 50% of academic duties, for a fixed-term period of three years. A Dean can serve for two periods of office.
- The current Heriot-Watt model of elected Deans is unusual in UK Higher Education, and was established in 2001/02 following the dissolution of Faculties, and the disestablishment of the office of (executive) Deans of Faculty.
- 5. The Deans fulfil a broad range of academic functions defined in Ordinances and Regulations (primarily regarding Quality Assurance and Standards, Student discipline; and Staff recruitment and promotion).
- 6. The Deans collectively and individually contribute to the senior fora of the University, including the Senate (of which all Deans are *ex-officio* members); one Dean is elected by the Senate to be a member of Court.

#### 2. Deans in Post

The Deans are elected for a period of three years, and there are three colleagues currently in post, who all are serving their first term of office and are eligible to stand for re-election:

- Professor Scott Arthur Dean (Arts, Humanities and Social Sciences) (elected until 31 March 2020);
- Dr Fadi Ghaith Dean (Science and Engineering) (elected until 31 December 2020);
- Dr Amos Haniff Dean (Pan-University) (elected until 31 December 2020).

#### 3. Constitutional Documents
